We respectfully submit the following points for your kind perusal and consideration:

First and foremost, we would like to extend a warm and wholehearted welcome to you as the CGM of BSNL TN Circle. We strongly believe that under your esteemed leadership, our circle will not only overcome the challenges it currently faces but will also regain its pristine glory, setting an example for other circles.

With reference to the letter cited above the corporate office issued guidelines that the long stay Inter circle transfers are carried out for 26/25 and 24 years, and to maintain the cycle now for the executives having stay more than 20 years are going to be considered for Inter circle transfers by corporate office in the cadres of SDE/AGM.

At this juncture we request that any transfer for the executives who has a long stay of 20 years and above in a station may be exempted from Intra circle transfer as they will be considered for Inter circle transfer. By considering the guidelines issued by corporate office multiple transfers may be avoided please.

Sir we strongly believe that the multiple transfers will surely reduce the working efficiency of the executives and also it affects their performances. We once again humbly request that the corporate office guidelines may be followed on intra circle transfers please

We are confident that this issue will be given the thoughtful consideration they deserve, and enhance the working environment for all BSNL executives.



Kind reference is invited to this office letter dated 02.02.2022 and 17.02.2023 under reference, vide which Inter-Circle transfers of SDE and above level executives on long stay basis have been carried out during the past 2 years. Initially the executives having Circle stay of more than 26 years were considered and later on the executives having Circle stay of more than 24/25 years (SDE/ AGM) were under taken.

In this regard, many Circles have raised the concern as to whether they should under take the Intra-Circle transfers of executives having station stay of more than 20 years or not, taking into account the hardships of executives if Inter-Circle transfers are done by the Corporate Office shortly after their Intra-Circle transfers by respective Circles.

Above matter has been examined and the undersigned has been directed to convey that henceforth Intra-Circle transfers of the executives having station stay of more than 20 years shall be avoided as their Inter-Circle transfers are being taken up by this office. However, Non-Territorial Circles may continue to take up their Intra-Circle transfers (with change in territorial area) on long stay basis.
