Circle Secretary elaborates the agenda point as follows.

- 1. As the fund position of TN Circle is deficit it is unable to print Diary, and so requested the branches to contribute as per the requirement of diaries @ Rs.165 per diary approximately.
- 2. The recent issues such as VRS 2.0 and PRC was discussed and as per CHQ the VRS2.0 is in the preliminary status and it will take time to discuss and the CHQ will update if they received any authentic information.
- 3. With respect to 3rd PRC it will happen only when some political decision taken to relax the affordability clause and it is not possible in near future.
- 4. It is requested all the branches to contribute their donations towards the Circle conference which was not paid during the conference to make the circle financial status healthy.
- 5. All branches are requested to conduct district conferences which are due.
- 6. With respect to AO to CAO promotions, CHQ stated that it is in before the court of law, a censes arrived between management and the association that to plea the court to promote all eligible candidates as there is ample no of vacancies and the seniority will be fixed after the outcome of court case.

The deliberations by the district secretaries are as follows.

- b. The circle meeting to be conducted periodically and the frequency to be increased.

4. Madurai.

- a. Subscription Quota to be given once in a quarter.
- b. It is requested that CHQ must supply Diaries and calendars every year at par with the other associations as we are contributing 60% to the CHQ.
- c. The upgradation training for Account officers to be conducted in RGMTTC Chennai.
- d. The long stay transfers of AOs should be transparent and it should be considered equally in all Bas.
- e. District conference will be conducted early.
- f. Ready to contribute for diary 2025.

5. Cuddalore.

- a. Status of One PSU One Association to be addressed.
- b. The cases should be settled on its merit rather than the colour of Association if a proposal is denied for our association it should be maintained if represents on the other channel.

As per the suggestions and points discussed by all DSs Circle secretary on his reply stated that.

- 1. In next CWC we on behalf of TN Circle would urge the CHQ to supply Diaries and Calendars to circles every year at par with the other associations.
- 2. The subscription quota to CBE will be dealt with our Ex FS and will be settled.
- 3. The regularisation of 2 JAOs , case will be taken by circle union and assure to take all efforts to settle.
- 4. TN Circle will urge CHQ to take the case of withdrawal of 1 increment on promotion.
- 5. The status of AO to CAO promotions, VRS 2.0 , One PSU One Association and PRC will be updated whenever we receive authentic information from CHQ .
- 6. The frequency of TN Circle meeting will be increased and it will be conducted periodically at least once in a month or bimonthly.
- 7. The upgradation training at RGMTTC Chennai the case will be raised in appropriate platform.
- 8. Suggestions are welcomed against the issues in transfer policy and they will be compiled and will be sent to CHQ.
- 9. TN Circle always insist that all the case will be raised and we urge the administration to hold on its decisions irrespective of associations.
- 10. The transfer cases of Smt. Ambika AGM, Smt Ilavarasi JAO and our Circle President will be discussed with administration and assure to take all efforts to settle.
- 11. TN Circle assure that if any injustice done to any of our members in any BA/OA if it was not able to settle by the branches we the Circle office bearers are there to settle the issues by negotiation and if needed by trade union actions.
- 12. TN Circle requests all the branches to contribute the donations pending towards the circle conference.
- 13. The Circle secretary and all circle office bearers are always open to any case and suggestions from all members and members may feel free to contact any of the office bearers.
