Subject: Request for Facilitating E3-E4 Training under EPP Upgradation for Accounts Officers -reg.

Respected Sir,

On behalf of AIBSNLEA, Tamil Nadu Circle, we wish to bring to your kind notice the serious difficulties being faced by Accounts Officers regarding the mandatory E3–E4 Training under the Executive Promotion Policy (EPP) upgradation.

At present, this training is being conducted only at RTTC, Jaipur, and the number of seats available per batch is very limited. As a result, not only in Tamil Nadu but also across all the Southern Circles (Tamil Nadu, Kerala, Karnataka, Andhra Pradesh & Telangana), a large number of Accounts Officers are still waiting to attend this training. Many of them are fast approaching the completion of the stipulated two-year period within which the training must be completed, as per EPP guidelines. Non-completion within this period will cause undue hardship and adversely affect their upgradation.

In this regard, we request your kind intervention to:

- 1. Ensure adequate nomination and allotment of seats for Accounts Officers of Tamil Nadu Circle in the forthcoming E3–E4 training batches.
- 2. Take up the matter with BSNL Corporate Office / Training Cell to extend the conduct of E3–E4 training to other RTTCs in South India, namely Chennai, Trivandrum, Hyderabad, and Mysore, so that the large number of pending officers from Southern Circles can be accommodated locally without depending only on Jaipur.
- 3. Since it is reported that faculty is not available in some RTTCs, it is suggested that willing Senior Accounts Officers may be utilized as faculty for these courses. This will overcome the faculty shortage and ensure smooth and timely conduct of the training.

We therefore solicit your kind support and early favorable action, which will provide immediate relief to the large number of waiting Accounts Officers across South India and enable them to complete their mandatory EPP upgradation training within the prescribed time frame.
